WAIVER FORM



BY SIGNING THIS FORM YOU ARE WAIVING IMPORTANT LEGAL RIGHTS.

PLEASE READ THIS FORM

1. This Waiver covers my participation in the following Dragon Boat Activities:
 - (a) Peekskill Celebration 2012 Dragon Boat Race, Saturday, August 4, 2012
 - (b) Practices at the Peekskill Celebration 2012 Dragon Boat Race practice site
 - (c) Any event involving dragon boat racing/practicing/instruction, or dry-land training exercises where 22DRAGONS is involved.

2. Participating in the above activities involve risks, dangers and hazards. For example, a boat could capsize or boats could collide in good or bad weather. I am aware that by participating in the above activities I am risking personal injury, death, or damage to property. I accept and assume those risks.

3. I release the following companies and people:
 - (a) 22DRAGONS
 - (b) City of Peekskill
 - (c) Peekskill Festivals, Inc.
 - (d) Peekskill Celebration 2012
 - (e) Peekskill Yacht Club
 - (f) Any and all sponsors of Celebration 2012 and/or the Celebration 2012 Dragon Boat Race
 - (g) The directors, officers, employees, agents, independent contractors and any volunteers of the above (all of whom are referred to as the Releasees in this Waiver Form), from any and all liability for any loss, damage, injury or expenses that I may suffer as a result of my participation in the activity above, no matter how caused, including if caused by the negligence of any of the Releasees.

4. If someone sues me for negligence, I agree not to claim contribution or indemnity from any of the Releasees. I release the Releasees from all liability that could arise from such a contribution or indemnity claim.

5. I agree to hold harmless and indemnify the Releasees in respect of any claims, liability or legal expenses that they incur arising directly or indirectly by reason of a claim brought by me against any person or entity for loss, damage, injury or expenses suffered by me. For example, if I sue a member of another team or my coach or a steersperson for negligence, and that person in turn claims contribution or indemnity from 22DRAGONS, then I am agreeing to pay 22DRAGONS for all liability claims and legal expenses that it incurs in connection with the contribution and indemnity claim.

6. I recognize and agree that I am not allowed to participate in the activity above unless I sign this Waiver. I agree that this Waiver is binding on me and on my heirs, executors, administrators and legal representatives.

Rules and Regulations for Safety and Conduct for Practicing and Racing on the Hudson River at the Celebration 2012 Dragon Boat Race Site

1. All dragon boat participants must wear an approved PFD at all times when practicing or racing at the Peekskill Celebration 2012 Dragon Boat Race Site. No exceptions.
2. All dragon boat participants must sign a waiver of liability before taking part in any dragon boat activity associated with Peekskill Celebration 2012 and 22DRAGONS. It is the captain's responsibility to ensure that all members of his/her crew have signed a waiver and to provide updated information for new members joining the team in the summer.
3. A certified level 1 coach or equivalent must be present with a crew, either in the boat or following on land, at all times during a crews practice.
4. The coach is the sole authority in the boat. He/She is to be respected at all times and will have final say on any matters concerning the safety and well being of the crew while a practice is underway.
5. Participants are responsible for the proper care of the Peekskill Celebration 2012 site and all 22DRAGONS equipment in their possession. Any damage to 22DRAGONS equipment or City of Peekskill property caused as a result of negligence or irresponsible behavior will simply be billed to the individual or team causing the infraction.
6. It is expected that all 22DRAGONS members conduct themselves in a sportsmanlike and respectful manner towards others whenever participating in any dragon boat activity associated with 22DRAGONS or its partners, namely Peekskill Celebration 2012, the Peekskill Yacht Club and the City of Peekskill. ***Failure to do so reflects poorly not only on the individual, but on our organization as a whole.***
7. Individuals or teams who fail to adhere to the above rules may face disciplinary action including have their paddling privileges revoked without refund.
